

Guidelines for Personal Ministry Overview and Release of Liability

The following guidelines for personal ministry are established to help facilitate the personal ministry sessions:

1. What are the spiritual requirements for coming to Touch of God International Ministries for Deliverance

- a) The person(s) desiring ministry must really want help. He or she must be serious about changing his/her life and keeping the deliverance after it is received
- b) If you have children who need ministry below the age of 16, it is necessary for the parent(s) to receive ministry beforehand to deal with generational curses. Then, parents should be present during ministry sessions with a child 14 and under.
- c) He/she must be totally honest in all sessions with those who will be ministering deliverance to them:

- Touch of God International Ministries keeps all All information given to the Deliverance Team is strictly confidential and will not be shared with anyone else where the person's name can be identified.
- The person receiving ministry must be candid and forthright in answering all questions as this aids the deliverance process.

2. What are the legal requirements to receive deliverance ministry?

The person receiving ministry must sign the online agreement form stipulating that any team member facilitating deliverance and healing ministry, that are under the legal covering of Touch of God International Ministry, will be held guiltless from any claims regarding spiritual, emotional, psychological, and/or physical results, or lack thereof, resulting from all deliverance sessions. 3. What are the practical requirements for coming to Touch of God International Ministries for deliverance?

- a. agrees to be prompt and on time for all sessions (in person or online through zoom)
- b. The person receiving ministry online through zoom needs to set it up ahead of time and must have a webcam and speakers, if not in person*
- c. If you have children, you must keep them quiet in a separate room.
- d. If you come in person for ministry, we do not have childcare or provide meals. Also, you are responsible for housing.*

e. The time assigned for ministry is based on Central Standard Time (cst). It is up to you to figure out your time if you are in another time zone.

4. What are the financial requirements of Touch of God:

There is a required charge for ministry, but if you make less than a certain amount, then discounts. We are a 501(c)3 and are tax deductible. Your contribution helps Touch of God to cover ministry expenses such as office, website hosting, and other expenses as well as helping three international ministries feed the poor, provide ministry materials, etc.

Cost if you make over \$1,500 per month:

- Two Hours – \$80.00
- Three Hours – \$110.00
- Four Hours – \$145.00
- Eight Hours – \$280.00

Cost if you make under \$1,500 per month (USA)

If you make less than \$1,500 per month and cannot afford the suggested payment, please **donate an amount** you can afford. Your contribution is a blessing, and we pray that every dollar is used wisely as well as pray blessings on your life.

By signing the electronic agreement form, Touch of God Team will provide quality deliverance ministry to people requesting personal ministry. Ministry average 2 hours the first session, and if scheduled for 2nd session, 1.5 to 1 hour each time thereafter.

GUARANTEE: The Deliverance Ministry Team guarantees their total, undivided attention and focus upon the person receiving ministry.

Release of Liability for Deliverance and Healing Ministry Counseling Services (please initial)

Section One - Regards to Doctors/Medicine

I do hereby enter into a personal ministry agreement with Touch of God International Ministries Ministry Team for deliverance and healing ministry sessions.

Touch of God International Ministries advises anyone taking medicine to not stop or to forego medical care, or mental health disease. The undersigned acknowledges and agrees that the very nature of their problem(s) is necessarily such that no specific result(s) can be promised or warranted by any ministry counseling services.

Section Two - Neglect or abuse of children

By law, there are certain situations in which information about individuals undergoing ministry may be released with or without their permission. These situations are as follows:

- When knowledge that children, under your care, or outside your care, are going through abuse, neglect, or in danger, then Touch of God, by law, must call the proper authorities.
- In emergency situations where there may be danger to the client or others, as with homicide or suicide, then confidentiality may be broken.
- If a court of law issues a legitimate subpoena relating to child abuse case, we are required by law to provide the information specifically described in the subpoena.
- If an unreported life-threatening felony has been committed, we are required by law to report it to the police.
- We also never advise anyone to stop their psychiatry care for mental health disease. We may deny our services.

Section Three - Licensed Therapists

- I acknowledge Touch of God International Ministries are not licensed counselors, therapists, medical or psychological practitioners. Ministers are prayer facilitators only.
- I am responsible for my own behavior, memories and life decisions. I take full responsibility for the results of my decisions, good or bad for my life.
- Touch of God International Ministries offers no guarantee for healing or deliverance.
- I understand that Touch of God International Ministries does not offer urgent care, emergency prayer, aftercare or mental health services.
- Touch of God International ministers reserve the right to discontinue ministry at any time for any reason. I acknowledge that active occult behavior may immediately terminate the ministry relationship.

Section Four - Appointment Policy

- - Ministry services are provided by appointment only.
 - To cancel or reschedule an appointment, please provide at least 24-hour notice.
 - Missed appointments will incur a one-hour fee (Discretionary).
 - As much as we love each person we serve, we aren't available for urgent or emergency support unless previously arranged directly by the minister. Please keep a mental health services number handy or dial 911 for emergencies or call 1-800-273-TALK (8255), if you feel the urge to commit suicide.
 - If a person does not contact within 24 hours and forgets, I may still minister. If the person fails to contact and does not show up the second time, I will refuse ministry.
 - Ministry is through zoom, and I require camera and audio, if not in person.
 - If you cannot fill out the forms because of equipment, then I may not be the right ministry.

Section Five - Acknowledgment and Release

The undersigned fully understands the nature of a healing and deliverance ministry counseling such as offered by Touch of God International Ministries. The undersigned waives and releases Touch of God International Ministries from any and all actions, courses of action claims, demands, damages, costs, loss of services, expenses and compensation, on account of any and all known and unknown personal injuries mental anguish or agitation and damage claims to person or property resulting from or arising out of, or related to, healing and deliverance counseling services and ministerial services at any point after the date of this release.

Section Six - Signature Section

In order to receive healing and/or deliverance ministry counseling from Touch of God, you must type in your full name (true name) in your name and date on the online ministry form.

The undersigned further states you have carefully read the foregoing release, know the contents thereof, and sign on your free act and deed.
